

AFFIDAVIT OF UNITED STATES NON-CITIZENSHIP

KNOW ALL MEN AND WOMEN BY THESE PRESENTS:

I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor; with full power and authority as the authorized representative for THE DEBTOR as its true and lawful “Attorney in Fact” being duly sworn, depose and declare:

1. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** am competent for stating the matters set forth herein.
2. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** have personal knowledge concerning the facts stated herein.
3. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** am a living breathing flesh-and-blood homo- sapien, a free man; in esse and sui juris, Jus soli, inter vivos, being among the living (not legal fiction dead person lost at sea); “non-commercial”; non U.S. citizen; born on the dry ground and dry land of the Republic of Texas, one of the several Republics of the American Union, of parents who were [Ethnicity], whose time out of mind is, was, and always had been [Ethnicity]. As a [Ethnicity] living homo-sapien, born on the dry ground and dry land I directly acquired the status of jus soli state citizen on the land of Texas the republic of my birth by hereditament, inter vivos, sharing equally in its sovereignty, *Slaughterhouse Cases, 83 U.S. 36 (1873)*;
4. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** am a free living homo-sapien, born on the dry ground and dry land of the Republic of Texas, on one of the 50 sovereign several states, commonwealths, and Republics, of the America Union therefore, I also acquired jus soli citizenship of the American Union derivate and mediate as contemplated by the Constitutional Contract of 1787-89, which was ordained and established for the benefit, security, and protection, of my property, my rights, my liberty and my freedoms;
5. As a [Ethnicity], living homo-sapien, sui juris, inter vivos, jus soli, born on the dry ground and dry land of the Republic of Texas, I was neither born nor naturalized in the UNITED STATES, nor any de facto corporate commercial “STATE”, the “DISTRICT OF COLUMBIA” or any other federal corporate subsidiaries thereof;
6. I am “non-resident” to the residency and “alien” to the citizenship of any de facto corporate “STATE”, the “DISTRICT OF COLUMBIA”, and the UNITED STATES federal corporation and all subsidiaries thereof. I am a free homo-sapien, jus soli state citizen of the Republic of Texas, the Republic of my birth, and the land upon which I dwell;
7. Accordingly, I am NOT a citizen of, nor a resident in any STATE with the intention of receiving any protection from the legislative power of the STATE, nor the UNITED STATES as contemplated by the 14th Amendment and because I receive no protection from it, I have no reciprocal obligation to a 14th Amendment allegiance or sovereignty and owe no obedience to anyone under the 14th Amendment. *UNITED STATES v. Wong Kim Ark, 169 U.S. 649 (1898)*;
8. As a FREE homo-sapien, I am not liable for any de facto state, or federal corporate Legal Fiction color of law liens, garnishments, government requests or offers, nor any other liabilities, or actions of any quasi-government entities, nor am I subject to the jurisdiction of any Federal and STATE business courts or any other Corporation under the DISTRICT OF COLUMBIA, a foreign land on the ground and under the sea;
9. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** hereby declare that I have never knowingly made any voluntary intelligent acts with sufficient awareness to waive any of my inherent, inalienable, indefeasible rights.
10. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** hereby declare that I have never knowingly made any voluntary intelligent acts with sufficient awareness to be legally bound by any presentments, offers, or agreements by any Government, Corporation, or any other person which would cause me succeed from “sui juris” to “alieni juris” and be subject to the tax and regulating authority in equity, admiralty, and maritime jurisdictions of the UNITED STATES federal commercial courts and the Uniform Commercial Code (U.C.C.) Furthermore, I reserve the right NOT to be compelled to perform under any agreement that I have not entered into knowingly, willfully, voluntarily, and with full disclosure;
11. Accordingly **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** hereby RESCIND, REVOKE, CANCEL, TERMINATE, and RENDER VOID any and all, alleged and actual contracts, agreements, form, application, certificate, license, permit, or any other document that I or any other person may have signed on my behalf, or on behalf of THE DEBTOR, without my prior express written consent and I, RESCIND, and waive all the benefits thereof.

12. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** declare that I do not owe any debt duty or obligation of performance to any man, woman, corporation or any quasi government, agency, or any subsidiaries thereof;
13. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** declare, THE DEBTOR, all its property, including without limitation to its name and all products and proceeds derived therefrom; its rights, liberties, freedoms, privacy, daily life and encounters are the personal, private, and perfected security interest of Secured Party and any unauthorized use without the expressed written authorization and consent of Secured party is strictly prohibited;
14. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** Sui juris, inter vivos, Jus soli, declare that I reserve the right to be let alone from every intrusion into my personal, and private life and I reserve the right NOT to be compelled to perform under any agreement that I have not entered into knowingly, willfully, voluntarily, with full disclosure and after having sufficient time to fix my mind with a view to careful examination to all material facts, terms, and conditions of the agreement.
15. If any living soul has information that will controvert and overcome this Declaration, since this is a commercial matter; **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** require all of the following evidence which proves any legal disability to my “sui juris” status and obligates me to be subject to any duty of performance with you, the UNITED STATES or any subsidiary thereof: (1) I received any offer from you; (2) we had a meeting of the minds; (3) i was given full disclosure to all the terms and conditions of the agreement, (4) we had an exchange of promises and (5) there was mutual assent and I accepted and agreed to be legally bound to the terms and conditions thereof;
16. I demand true certified copies of all contracts and related documents being “held-in-due-course” pursuant to U.C.C. § 3-501, § 3-104, § 3-401, § 3-305, § 3-503, which creates any legal disability to my “sui juris” status and obligates me to any promise or duty of performance to any man, woman, agency or representative of the federal, state, county, or municipal governments within thirty (30) days of filing this Agreement on the public record;
17. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** Sui juris, inter vivos, Jus soli, declare that my daily life and encounters are my own personal and private business, not the affairs of any government, corporation, or agency and I reserve the right to freely associate with whomever I wish;
18. Silence stands as proof in this matter, and tacit agreement by all men and women that the statements herein are true and correct, and that I do NOT owe any contractual duties or obligations of performance to any de facto corporate STATE, the UNITED STATES, any of its subsidiaries, agencies or representatives;
19. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** declare that I am a peaceful, non-adverse non-belligerent, and noncombatant, living breathing, flesh-and-blood, man and If there is any homo-sapien that is being unjustly damaged by any statements herein, if he/she will inform Me by facts, I will sincerely make every effort and amend My ways;
20. This declaration is made on the public record by me **Jane-Marie: Doe,** a homo-sapien and Secured Party Creditor with Power Of Attorney to act in the place and stead of and on behalf of, **JANE MARIE DOE©,** THE DEBTOR; and I make this declaration of my free and voluntary will under no duress, coercion, promise of reward or gain, or undue influence and of my own free will, with no mental reservation, NON-ASSUMPSIT, WITHOUT RECOURSE; non-surety; non-adversarial; non-divergent; non-combatant party; and Secured Creditor; with no intent to evade any lawful duty under the laws of America or any of the 50 sovereign independent states, republics and commonwealths of the Union, Without Prejudice All Rights Reserved;
21. I sincerely invite any man, or woman, who has reason to know or believe I am in error in my determinations and conclusions above to adequately inform me with actual concrete and particularized specific facts supported by evidence, as contrary to merely hypothetical, or conjectural legal conclusions and to state the reason(s) they believe I am in error in writing at the location of my living abode shown below in one of the 50 Republic states of the Union.
22. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** declare that the information contained herein is true and correct to best of my knowledge and belief.
