## AFFIDAVIT NO JURISDICTION IMPLIED OR ASSUMED

KNOW ALL MEN AND WOMEN BY THESE PRESENTS:

**I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** with full power and authority as the authorized representative for THE DEBTOR as its true and lawful “Attorney In Fact” being duly sworn, depose and declare:

1. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** being of sound mind and lawful age am an American (non U.S. citizen); inter vivos, being among the living (not legal fiction dead person lost at sea); “non-commercial”; non-surety, and I am a Free living homo-sapien, Sui Juris, Jus soli, born on the Republic of **California**, of parents whose time out of mind were and always had been White.
2. As a [**Ethnicity**] living **homo-sapien**, born on the dry ground and dry land I directly acquired the status of jus soli state citizen on the land of **California** republic of my birth by hereditament, inter vivos, sharing equally in its sovereignty, *Slaughterhouse Cases, 83 U.S. 36 (1873)*. Therefore I was neither born nor naturalized in, nor am I a resident of the UNITED STATES any of its contracted de facto corporate commercial “STATES” or any other subsidiary thereof.
3. As a non-resident alien in relation to the UNITED STATES, I am not restricted by the 14th Amendment, and because I receive no protection from it, I have no reciprocal obligation to a 14th Amendment allegiance or sovereignty and owe no obedience to anyone under the 14th Amendment. *UNITED STATES v. Wong Kim Ark, 169 U.S. 649 (1898)*.
4. THE DEBTOR known as **JANE MARIE DOE©** is an incorporeal Ens Legis, a creature of the law, created by contract, to serve as a conduit for the purpose of exchanging goods, services, obligations, and liabilities in commerce; however it has been, and is continuing to be used to extort commercial energy from the homo-sapien known as **Jane-Marie: Doe** without their willful and voluntary consent.
5. THE DEBTOR, all its property, including without limitation to its name, its rights, and all products and proceeds derived therefrom, is the personal, private, and perfected security interest of Secured Party and any unauthorized use without the expressed written authorization and consent of Secured party is strictly prohibited.
6. I hereby declare that I have never knowingly made any voluntary intelligent acts with sufficient awareness to waive any of my rights nor did I agree to any of the terms and conditions set forth in any instruments, contracts, agreements or any other document, offered by the UNITED STATES corporation including without limitation to Application for STATE OF **California** Certificate of Live Birth # **123-45-6789**, application for social security # **123-45-6789**, STATE OF **CALIFORNIA** Driver License # **123456789**.
7. I reserve the right NOT to be compelled to perform under any agreement that I have not entered into knowingly, willfully, voluntarily, with full disclosure and after having sufficient time to fix my mind with a view to careful examination to all material facts, terms, and conditions of the agreement.
8. I will only consider contracts mailed by certified carrier to **555 Free Will Turnpike. Los Angelas, California [90210]** (**everything completely spelled out, no abbreviations, zip code in brackets, just like shown**) as it is against the Corporate U.C.C., FEDERAL, and United Postal Union law to accept another person’s mail that does not belong to this living man under Title 18.
9. As a Free homo-sapien born on the dry ground and dry land of **California**, I acquired sui juris citizenship on the land of my birth, and I am a non-resident alien with respect to the UNITED STATES and I have no legal or lawful contracts with DC franchises any and all alleged debts, duty or obligations of performance are void on the basis of fraud including but not limited to fraudulent concealment and fraudulent misrepresentation. I only use the aforementioned documents, under undue influence, threat, duress, protest, coercion and due to necessity as I have been fraudulently induced into using the aforementioned documents without full disclosure of the terms therein and being misled by alleged government and

corporation agents, officials, and representatives that using these commercial paper and STATE Government documents were mandatory.

10. Wherefore, a lack of standing deprives a court of jurisdiction, and the minimum requirement of standing requires that a claimant must have suffered a concrete and particularized injury in fact with a causal nexus to the wrongdoer, as a peaceful, non-adverse, non-belligerent, and non-combatant sentient living, breathing, flesh-and-blood homo-sapien, who has not caused harm to anyone, and I have not knowingly made any voluntary acts agreeing to enter into any contracts which obligate me to perform any duty, or obligation with the UNITED STATES, any of its subdivisions, agencies, contractors, representatives, agents, officers, or affiliates thereof, I do not consent to the jurisdiction of any court, or tribunal;

Therefore, any and all alleged debts, duties, and obligations of performance in any manner whatsoever in relation to any alleged legal relations I may have with the UNITED STATES are void on the basis of fraud, and duress; and no jurisdiction shall be implied or presumed in regards to any debt duty or obligation that may arise from any presumed contracts including but not limited to the Application for STATE OF California Certificate of Live Birth #010-45-678912, application for social security #123-45-6789, STATE of CALIFORNIA Driver License #123456789 and any other presumed debt, duty, or obligation of performance which arises therefrom, without full disclosure of all the terms and conditions of the aforementioned agreements so that I can have sufficient awareness of the relevant circumstances and likely consequences to make an informed and voluntary decision.
12. **I, a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor;** demand true certified copies of any and all contracts, agreements, forms, instruments, applications, certificates, licenses, permits, and any other document being “held-in-due-course” which allegedly obligates me to any duty of performance to any man, woman, agency or representative of the federal, state, county, or municipal governments pursuant to and in accordance with U.C.C. § 3-501, § 3-104, § 3-401, § 3-305, and § 3-503. If any man or woman is alleging that I do owe any debt duty or obligation to you I require you to provide any and all of the following evidence and all related documents which proves I am subject to any duty or obligation of performance: (1) I received any offer from you; (2) we had a meeting of the minds; (3) I was given full disclosure to all the terms and conditions of the agreement, (4) we had an exchange of promises and (5) there was mutual assent and I accepted and agreed to be legally bound to the terms and conditions thereof.

This declaration is made on the public record by me, **a homo-sapien: Jane-Marie: Doe, and Secured Party Creditor,** with Power Of Attorney to act in the place and stead of and on behalf of, **JANE MARIE DOE**©, THE DEBTOR; and I make this declaration of my free and voluntary will under no duress, coercion, promise of reward or gain, or undue influence and of my own free will, with no mental reservation, NON-ASSUMPSIT, WITHOUT RECOURSE; non-surety; non-adversarial; non-divergent; non-combatant party; and Secured Creditor; with no intent to evade any lawful duty under the laws of America or any of the 50 sovereign independent states, republics and commonwealths of the Union, Without Prejudice, All Rights Reserved;
14. I sincerely invite any man, or woman, who has reason to know or believe I am in error in my determinations and conclusions above to adequately inform me with actual concrete and particularized specific facts supported by evidence, as contrary to merely hypothetical, or conjectural legal conclusions and to state the reason(s) they believe I am in error in writing at the location of my living abode shown below in one of the 50 Republic states of the Union.
